### Education and Individuals – Goal #1

**Goal:** Increase individual knowledge of HIV among populations who are especially hard to reach, which includes general and local HIV prevention and care service information.

#### **Key Activities**:

- (Year 1). Set up an HIV Education Advisory Board for each of five hard to reach populations. The Advisory Board will be co-chaired by three individuals, two of whom will represent the population being addressed. Populate the Board with additional individuals who represent the population being addressed and community partners who bring specific knowledge and resources to the project. Find or develop a curriculum for each of the five groups: adolescents, college students, Latina women, senior citizens and one more group to be determined (possibly cisgender women of color or people who inject drugs or use methamphetamine or crack.) Add a component to the training that includes local HIV prevention and care service information
- (Year 2) For each of the five HIV Education Advisory Boards, select an already existing group, such as a college or an agency that offers services to mono-lingual individuals. Work with this institution, organization or group to implement a pilot project. Select one professional instructor and 2 3 student peers to co-teach the curriculum. Through pre and post tests, measure the impact of the training on each population. Work with the institution, organization or group so that the training continues for at least three more years.
- (Year 3, 4 and 5) Revise the curriculum based on the results of trainings and select new institutions and organizations, or continue working with groups whose membership changes regularly. For each group of students, use the pre and post tests to measure the impact of the training.

# Education and Individuals: Adolescents

**Goal:** Increase individual knowledge of HIV among **Adolescents**, which includes general and local HIV prevention and care service information.

**Key Activities**: Set up an HIV Education Advisory Board for an organization that manages high schools (such as AAMA Sanchez Charter Schools). Locate an already existing curriculum or, in the absence of a curriculum that meets select criteria, create an HIV prevention and care curriculum for adolescents. Ask the school to identify teachers and students who are trained to co-facilitate classes based upon the curriculum. Use pre and post tests to measure the impact of the training on the students. Adjust the curriculum when necessary and make the program available throughout the high school and to other local high schools.

**Key Partners:** The Association for the Advancement of Mexican Americans (AAMA) Sanchez Charter Schools, The Houston High School for the Performing Arts, Houston Independent School District, Covenant House, AIDS Foundation Houston, Texas Southern University Education Department, representatives of the Houston Ryan White Planning Council and the Houston Prevention Community Planning Group (CPG), Houston Health Department, Harris County Health Department and others.

# Education and Individuals: College Students

**Goal:** Increase individual knowledge of HIV among **College Students**, which includes general and local HIV prevention and care service information.

**Key Activities**: Set up an HIV Education Advisory Board for a local college or university (Texas Southern University has already committed to the project). Locate an already existing curriculum or, in the absence of a curriculum that meets select criteria, create an HIV prevention and care curriculum for college students. Ask the college/university to identify 1 - 2 professors and several students who are trained co-facilitate classes based upon the curriculum. Use pre and post tests to measure the impact of the training on the students. Adjust the curriculum when necessary and make the program available throughout the college/university and to other local colleges and universities.

**Key Partners:** Texas Southern University (TSU), SHAPE Program at TSU, AIDS Foundation Houston, Ambassadors for Christ, representatives of the Houston Ryan White Planning Council and the Houston Prevention Community Planning Group (CPG), Houston Health Department, Harris County Health Department and others.

**Potential Funding Resources:** Texas Southern University grant funds and/or Ambassadors for Christ grant funds, some of which have already been secured.

# Education and Individuals: Latinx Individuals

**Goal:** Increase individual knowledge of HIV among **Latinx Individuals who were born outside of the United States.** The curriculum will include general and local HIV prevention and care service information.

**Key Activities**: Set up an HIV Education Advisory Board for a local organization that serves individuals born outside of the United States (such as the Association for the Advancement of Mexican Americans, or AAMA). Locate an already existing curriculum or, in the absence of a curriculum that meets select criteria, create an HIV prevention and care curriculum for individuals who are taking classes at the organization, such as English as a First Language. Ask the organization to identify 1 - 2 instructors and several students who are trained to co-facilitate classes based upon the curriculum. Use pre and post tests to measure the impact of the training on the students. Adjust the curriculum when necessary and make the program available throughout the organization and in other organizations that serve people born outside the United States.

**Key Partners:** The Association for the Advancement of Mexican Americans (AAMA), Fundacion Latino Americana de Accion Social (FLAS), Texas Southern University, representatives of the Houston Ryan White Planning Council and the Houston Prevention Community Planning Group (CPG), Houston Health Department, Harris County Health Department and others.

Potential Funding Resources: Texas Southern University grant funds.

# Education and Individuals Senior Citizens

**Goal:** Increase individual knowledge of HIV among **Senior Citizens throughout the 10-county service area.** The curriculum will include general and local HIV prevention and care service information.

**Key Activities**: Set up an HIV Education Advisory Board for a local organization that serves senior citizens throughout the 10-county service area (such as local multi service centers and the Area Agency on Aging). Locate an already existing curriculum or, in the absence of a curriculum that meets select criteria, create an HIV prevention and care curriculum for individuals who are taking classes at the multi service centers. Ask the organization to identify 1 - 2 instructors and several students who are trained to co-facilitate classes based upon the curriculum. Use pre and post tests to measure the impact of the training on the students. Adjust the curriculum when necessary and make the program available to other organizations that serve senior citizens.

**Key Partners:** Houston Area Agency on Aging, Texas Southern University, Houston Area Multi Service Centers, Harris County Multi Service Centers, HIV and Aging Coalition, LGBTQ Aging Coalition, representatives of the Houston Ryan White Planning Council and the Houston Prevention Community Planning Group (CPG), Houston Health Department, Harris County Health Department and others.

# Education and Individuals – Goal #2 Individuals with a History of a Sexual Offence

**Goal:** Increase individual knowledge of HIV, including HIV prevention and care services information, among individuals with a **history of a sexual offence**.

**Key Activities**: Employ one full time person with lived experience to provide HIV education and case management services to this population. Locate an already existing curriculum or, in the absence of a curriculum that meets certain criteria, create an HIV prevention and care curriculum for individuals with a history of sexual offense. Train 2 - 3 individuals who have been released from jail or prison to work with the case manager to co-facilitate classes based upon the curriculum. Use pre and post tests to measure the impact of the training. Adjust the curriculum to improve the effectiveness of the program and make the curriculum available to other communities.

(Year 1) Request the Ryan White Planning Council to create a service definition and allocate funds for the position from Ryan White Part A, B or State Services funding. If approved, release the RFP and secure a vendor for the contract.

(Year 2) Hire and train the employee. The employee will provide the training, the pre and post tests and provide case management services to clients who are living with HIV and have a history of committing a sexual offense.

**Key Partners:** St. John's Church Downtown, Houston District Parole Office and/or Texas Department of Criminal Justice Parole Office, Ryan White Program Part A or B

Potential Funding Resources: Ryan White Program Part A or B

**Estimated Funding Allocations:** \$90,000

# Education and Providers – Goal #1

**Goals/Goal:** Educate staff at local non-Ryan White funded agencies in the basics of HIV and process for referring a client/patient to agencies in the 10-county service area for HIV prevention and care services.

The curriculum will include general and local HIV prevention and care service information.

#### **Key Activities**:

- (Year 1) Set up a small HIV Education Advisory Board that includes representatives from the South Central AETC Program and perhaps United Way of Greater Houston. Locate an already existing curriculum or, in the absence of a curriculum that meets select criteria, create an HIV prevention and care curriculum for individuals in non-Ryan White funded agencies who may have clients living with HIV. Follow up with at least 3 area agencies who requested HIV training for their staff during stakeholder interviews for this integrated plan: Houston Area Women's Center, Houston Independent School District Partner Resources and Harris Center for Mental Health. Use pre and post tests to measure the impact of the training on the agency staff. Adjust the curriculum when necessary and make the training available to other non-Ryan White funded agencies throughout the 10-county service area.
- (Year 2) Conduct/implement the pilot project with at least one other mainstream mental health or substance use disorder facility to teach their healthcare workers how to refer patients to local HIV organizations.
- (Year 3) Revise the curriculum based on the results of the pilot project.

**Key Partners:** The South Central AIDS Education & Training Center (AETC); United Way of Greater Houston; Ryan White Grant Administration, The Houston Regional HIV/AIDS Resource Group and others.
