Legislative Issues: Walker stated that for the third year in a row the government will not have a budget as of October 1, 2004.

Mayor's Task Force on HIV/AIDS: Walker stated that there is a retreat planned to discuss the continuation of the Mayor's Task Force, and what direction it should go in if continued.
