Mayor's Task Force on HIV/AIDS: Robinson IV stated that Tuesday, February 7, 2006 was National HIV Awareness Day Among African-Americans. A press conference was held regarding the State of Emergency. Several dignitaries and radio stations participated. The House of Hope has opened and there will be another outreach site at W. Montgomery and Little York.

Fuentes, Jr. requested that the Latino Task Force be added as a regular agenda item. Garza, D. is a member and offered to provide reports.

SCSN: Mierstchin stated that there will be a meeting in Dallas next week. The purpose is to complete the 2006 Texas Statement of Need. Due to budget cuts, SCSN will go out of existence on April 1, 2006. A meeting of all planning bodies and administrative agents will convene to address group changes and make all aware of future dates.

HOPWA: Williams, T. stated that at the last PWA Housing Advisory Group meeting the national HOPWA technical advisor, Andrea White, presented valuable information.
