Report from Titles II, III urban and rural, IV and Section F: Proctor stated that Title II would like to use the Title I Priority and Allocations Committee to complete it's planning process for Title II and State Services funding. She was surprised how large Houston and Texas actually are and thought she could cover the entire area in only a few days. Proctor added that the same project officer did site visits in her office for Title III Rural and Title IV.

Report from the CDC Planning and Prevention Group: Robinson stated that CPG is in the process of prioritizing its populations and interventions. The group still needs members. Please email him for an application.

Mayor's Task Force on HIV/AIDS: Robinson stated that June 27, 2006 was National HIV/AIDS Testing Day. Many organizations held testing events. Later that evening they attended a Town Hall meeting that was held at Wheeler Avenue Baptist Church.

Latino Task Force on HIV/AIDS: Vargas stated that there were several Latino testing events also on National HIV/AIDS Testing Day. He is waiting to find out how many people were tested that day.

HOPWA: Gray stated that July 20, 2006 is the deadline for submitting grant applications to HOPWA. Her department is hoping for a 90-day turn around on the applications. HOPWA now has a page on the City of Houston website. This page will include information for clients, contractors and others and will hopefully be up and running by September. The Black Democrats will host advocacy training and a legislative update on July 23, 2006 in the rotunda area of City Hall.
