**Report from HIV Services**: Charles Henley, HIV Services, Harris County Health Department, summarized the attached report. Henley stated that Family Services of Greater Houston has decided to no longer accept Ryan White funds.

**Old Business:** Turner stated that Modelle Brudner recently retired but she is a part time employee and continues to be the Council liaison for County Judge Ed Emmett.

#### **New Business:**

Report from Ryan White Parts B, C Rural and D: Yvette Garvin stated that since the Part B and State Services allocations have been approved, bids will be going out.

Ryan White Titles C Urban and D: Pete Rodriquez stated that the HRSA Office of Performance Review will be in Houston visiting the Harris County Hospital District (and others?) from October 1 through November 1, 2007.

Report from the CDC Planning and Prevention Group: Samuel Robinson stated that applications for membership are available. Progress Reports will be presented at the next meeting which is scheduled for 3:00 p.m. on Thursday, October 25, 2007, location to be announced. Wiley stated that the City Council has approved 8 prevention contracts.

Mayor's Task Force on HIV/AIDS: Samuel Robinson stated that the next meeting will be at 11:00 a.m., on October 12, 2007 at 8000 Stadium Drive. The Task Force Policies and Procedures will be finalized. On November 16, 2007 there will be a retreat where all members will honor Ada Edwards. On November 7, 2007 there is a "Bet Rap It Up" Campaign at Texas Southern University. Free testing will be available.

Latino Task Force on HIV/AIDS: Steven Vargas asked Council members to help distribute the attached flyer dated October 15, 2007. The next meeting will be at 10:00 a.m. on Wednesday, October 24, 2007 at the Women's Center.

**Announcements:** Health Planner Kim asked members to distribute the attached flyer concerning two upcoming Latino Focus Groups.

Dr. Giordano stated that Baylor and the Harris County Hospital District (HCHD) has received a CDC/HRSA Grant in the amount of \$1.5 million that will focus on studying and developing methods for improving retention in care for people with HIV/AIDS. Six sites have been selected to receive these CDC funds for 5 years. Rodriguez stated that last year at the Harris County Hospital District, 624 patients that were in care, dropped out of care.

Wiley stated that the City has extended its Syphilis Rapid Response Program for another month. 24 new HIV cases have been found.

Burton stated that plans are being made for the Interfaith Service for World AIDS Day on Saturday, December 1, 2007. Also Covenant Baptist Church has some funds for small non-profit groups.

Turner asked that if anyone plans to attend the Town hall meeting at the Montrose Counseling Center. If so, could they bring back a report for the Council.
