**Call to Order**: Bruce Turner, Chair, Ryan White Planning Council, called the meeting to order at 11:38 a.m. and asked for a moment of reflection.

Update on Houston Area SPNS Project: Thomas Giordano, MD, presented the attached Power Point presentation highlighting the latest results of the Houston Area SPNS Project.

Turner introduced the two new Council Members: Dan Ellis, Substance Abuse Expert and Linda Hollins, State Part B Representative.

Turner thanked Henley for all of his hard work in submitting the Part A HRSA grant application.

### **Reports from Committees:**

**Quality Assurance Committee**: Glenn Taggart, Co-Chair, reported on the following:

Standards of Care/Outcome Measure Workgroups: Recommendations regarding the FY 2008 Standards of Care and Outcome Measures will be presented to the Steering Committee and Council in December 2007. Williams stated that the three work groups were well attended by Affected Community Committee members and others.

### <u>Comprehensive HIV Planning Committee</u>: Steven Vargas, Chair, gave the following reports:

Update on the 2008 HIV/AIDS Needs Assessment: See the attached preliminary data for the needs assessment. The Gaps Analysis Workgroup will be meeting every other week starting on Thursday, November 15, 2007. The purpose of this workgroup is to prepare the needs assessment report for review and approval by the NAG on Thursday, December 20, 2007. The Comprehensive HIV Planning Committee will meet right after the NAG meeting. The Council will receive the report for review and approval in February 2008.

#### **Affected Community Committee:** John Tuttle, Co-Chair, reported on the following:

Monthly Educational Presentation: Michael Alexander worked with the committee on improving their public speaking skills.

Blue Book Workgroup: See the attached changes that are being considered for the 2008 – 2009 Blue Book. Jackson stated that today, prior to the Council meeting, the Blue Book Workgroup approved the proposed changes and selected the cover for the book.

Quarterly Committee Report: See the attached.

#### **Operations Committee:** David Bartholomew, Chair, reported on the following:

Proposed Changes to the Council Bylaws and Policies: According to the bylaws, proposed changes must be submitted in written form to the full Council at least 15 days prior to voting and require a two-thirds

majority for passage. Therefore, the attached, proposed changes to Council bylaws and policies are being submitted as an FYI in November so that the Council can vote on them at their meeting in December.

Memorandum of Understanding: *Motion #3:* The Committee recommends that the current Memorandum of Understanding stay in place as is and be reviewed again in October 2008. *Motion carried.* 

Election for the 2008 Council Officers: Please review the attached election policy, and, see the slate of nominations for the three officer positions. The election will take place at the December 2007 Council meeting.

**Priority & Allocations Committee**: Paula Downes, Co-Chair, gave the following reports:

FY 2007 RW Part A Requests for Increased Allocations: *Motion #4:* To accept the attached recommendations for the FY 2007 Ryan White Part A increase allocations. *Motion carried.* Abstentions: Bartholomew, Malone, Downes, Watson, Giordano, Hollins, Rodriguez, Wiley.

Unspent Funds: Motion #5: In the final quarter of the Ryan White Part A grant year, after implementing the Council-approved October reallocation of unspent funds and utilizing the existing 10% reallocation rule to the extent feasible, HIV Services may reallocate any remaining unspent funds as necessary to ensure the Houston EMA has less than 2% unspent Formula funds and no unspent Supplemental funds. HIV Services must inform the Council of these shifts no later than the next scheduled RWPC Steering Committee meeting. Motion carried. Abstentions: Watson, Hollins, Wiley.

Joint Meeting to Review 2008 Data Needs: There will be a joint meeting of the Priority and Allocations, Quality Assurance and other Committees to review 2008 data needs at 9:30 am on Wednesday, November 14, 2007.

**Report from Office of Support**: Tori Williams, Manager, summarized the attached report. Williams stated that the December Council Meeting will be held at the Dunn Center in downtown Houston. The Center houses a number of programs for the homeless so a tour will be provided immediately following the Council meeting.

**Report from HIV Services**: Charles Henley, HIV Services, Harris County Health Department, summarized the attached report.

#### **New Business:**

PC Members: Shelton summarized the attached report regarding HIV related items discussed at the first Native American Health Conference. Shelton stated that there is a lack of knowledge about HIV/AIDS among Native Americans. Texas has the fourth largest population of Native Americans in the country and Houston is the eleventh largest city in this same regard.

Ryan White Titles C Urban and D: Turner congratulated Pete Rodriquez for his new position as the administrator for Thomas Street Clinic. Rodriquez stated that a HRSA Technical Assistance Team recently made a site visit to the clinic.

Report from the CDC Planning and Prevention Group: Wiley stated that the Houston prevention needs assessment should be available for distribution on November 15, 2007.

Mayor's Task Force on HIV/AIDS: Wiley stated that the "Wrap It Up" testing program held at Texas State University tested some 250 students. One person tested positive. The Task Force will be holding a retreat on November 16, 2007.

Latino Task Force on HIV/AIDS: Vargas stated that the next meeting will be held at the Houston Women's Center beginning at 10:00 a.m. on November 28, 2007.

HOPWA: Tuttle stated that the HIV/AIDS Housing Needs Assessment is available and is being distributed to City officials and others.

Announcements: Tuttle announced the following World AIDS Day Events:

11:00 a.m., Thomas Street Clinic: There will be a Tree of Remembrance Ceremony and featured speakers include: Ada Edwards, Dena Gray and a representative from County Judge Ed Emmett's office.

11:30 a.m., Ben Taub Hospital: There will also be a Tree of Remembrance Ceremony and featured speakers will include: Congresswoman Sheila Jackson Lee, a representative from Judge Emmett's office and others.

Tuttle also stated that Thomas Street Clinic will be hosting a sit-down Thanksgiving Dinner. Donations are needed.

Wiley stated that there will be a "Straight Talk Summit" on November 9, 2007 from 5:00 p.m. to 9:00 p.m. at Texas Southern University (TSU). The City of Houston's World AIDS Day ceremony will be held at TSU on Saturday, December 1, 2007 from 12:00 p.m. to 3:00 p.m.
