**Call to Order**: Bruce Turner, Chair, Ryan White Planning Council, called the meeting to order at 11:40 a.m. and asked for a moment of reflection. Turner gave a special welcome to members of the Project LEAP class, guest speaker Dr. Stanley Lewis and Council Member Garrison.

Adoption of the Agenda: <u>Motion #1</u>: it was moved and seconded (Vargas, Seymore) to adopt the meeting agenda. Motion carried.

Adoption of the Minutes: <u>Motion #2</u>: it was moved and seconded (Ross, Givens) to adopt the July 11, 2009 minutes. **Motion carried**. Abstentions: Giordano.

Training: HIV and Mental Health: Dr. Stanley Lewis, St. Hope Foundation, presented the attached power point presentation entitled: *Mental Illness & HIV*.

### **Public Comment:**

Ann Reed, Bering Omega Community Services: Bering Omega is collaborating with Montrose Counseling Center to do testing at a homeless shelter and link clients to care. Omega House is now offering respite services. The Day Center offers many activities for clients who attend. The Dental Clinic no longer has block appointments; there is a new system where clients can fill an appointment slot for someone who cannot make it on that day.

Crystal, on behalf of the Project LEAP class, stated the Project LEAP students were very happy to be attending the Council meeting.

## **Reports from Committees:**

Quality Assurance: No report.

Comprehensive HIV Planning Committee: Steven Vargas, Chair, reported that the attached TB and utilization data (Question 2.1) will be incorporated into the *2009 Houston Area Joint Epidemiological Profile*. Also, the attached report entitled: New Cases for 2007 is very interesting; it shows the number of new HIV cases that progressed to AIDS within the same year.

Affected Community Committee: Greg Monk reported that the Consumer Gala Health Fair workgroup is working in conjunction with Ryan White Grant Administration to put together a consumer workshop. It was originally planned to take place in late 2009 but due to scheduling problems it will take place in February 2010. Several members are going to do site visits to select the venue and the committee will let Council know when the date has been finalized because Council members will be needed to assist on the day of the event. Ruben Rosas, Co-Chair, reported that in July the committee met at Legacy Community Health Services. The consumer educational presentation was entitled: The Houston Meth Epidemic.

Operations Committee: Greg Monk reported that the date of the all-day 2010 Council Orientation will be Thursday, January 28, 2010. Please mark your calendars now for this important event. **Report from Office of Support**: Tori Williams, Manager, summarized the attached report. She encouraged members who could stay afterward to stay to answer questions from Project LEAP students. Turner presented Williams with a card from the Council and wished her a happy birthday.

Report from Ryan White Grants Administration: Charles Henley, Manager, Ryan White Grant Administration (RWGA), Public Health and Environmental Services, summarized the attached report.

#### New Business:

Report from Ryan White Parts B, C Rural and D: Patrick Martin summarized the attached report.

Report from Ryan White Part F SPNS Project: Henley explained that SPNS is a special project of national significance which is funded under Ryan White Part F. Houston received a five-year demonstration project to identify young men of color who are positive and link them to care. There are 7 other sites across the country participating in this project. As of the second week in August 2009, the Houston project had identified 49 positive individuals and linked them to care. In September 2009 the project will be transferred to Part A.

Mayor's Task force on AIDS: Baldwin reported that the task force would be meeting on August 14, 2009 at noon at the Houston Department of Health and Human Services building on North Stadium Drive.

Latino Task Force on HIV/AIDS (LHTF): Steven Vargas gave the following report: The two preliminary positives from HIV Testing Day have been confirmed. The last meeting on July 24, 2009 was held at Thomas Street Health Center in the 3<sup>rd</sup> floor conference room; all remaining meetings for the year will take place at this location. Meetings are held on the last Friday of every month starting at 11:00 a.m. and everyone is welcome. Latino HIV Awareness day is October 15<sup>th</sup> so plans are being made for that.

Legislative Updates: See the attached Legislative Update from Ken Malone. Henley said there is a lot going on with health care reform right now so it's very confusing. The Ryan White Program must be reauthorized to continue.

HOPWA: Keith W. Bynam stated that the staff will be having a training on the new SSI/SSDI Outreach, Access and Recovery (SOAR) program later this year. The goal of the program is to increase access to Social Security disability benefits; PWAs will get benefits sooner and not have to wait in line.
