Affected Community Committee: Ruben Rosas, Co-Chair, reported on the following:

Consumer Workshop: Monk, Co-Chair, stated that the next meeting will be at 12:00 p.m., Wednesday, November 4, 2009 in room 240. Martin designed the attached blue flyer for Vendors application – space is limited.

Consumer Education: At the September meeting there was an educational presentation by Paul Simmons, RN entitled, "Myths and Facts about Re-Transmitting HIV". It was very good and included an open discussion. He said he would be happy to do the presentation at a Council meeting as well.

Community Events: The most recent event was at the Harvest Time church. Rosas worked the event and said it was well attended. The events remaining for this year are the Women's Festival on Saturday, October 24, 2009 and World AIDS Day. Report from Office of Support: Tori Williams, Manager, summarized the attached report. Soon, the Houston EMA Ryan White Part A grant application will be available to Council members who wish to proofread it. Report from Ryan White Grants Administration: Charles Henley, Manager, Ryan White Grant Administration (RWGA), Public Health and Environmental Services, summarized the attached report.

#### New Business: Reports:

CDC Planning and Prevention Group: Wiley stated that their CDC grant application is currently under review by the Community Planning Group (CPG).

Mayor's Task Force on HIV/AIDS: Wiley stated that the State of Emergency Task Force (SOE) is helping the Latino Task Force promote their upcoming activities.

Latino Task Force on HIV/AIDS: Vargas stated that the Latino HIV Task Force is still working on plans for National Latino AIDS Awareness Day on October 15, 2009. They have secured three separate testing sites at community based, faith based and commercial locations. Each is located in a different area of the city. The Task Force is hoping to reach a much broader segment of the community than in the past. Radio announcements will begin on Monday, October 12, 2009.

Announcements: Turner announced that Morenike Giwa has been appointed to a national committee that has input into clinical trials for NIAD, specifically, the Community Science Subcommittee of the AIDS Clinical Trials Group (ACTG). This committee establishes the committee's priorities for the HIV scientific research agenda. Every member of the committee serves on one or more protocol teams, and some members of the committee also serve on the ACTG's RACS (research agenda committees), which develop a research agenda in a specific area (e.g., therapeutics, immunology, etc). The 26 members of this committee are selected from ACTG sites around the world. (Houston's site is at the University Of Texas School Of Medicine.)

Invitations to attend the Project LEAP graduation are available from Turner.

Fisher will be moving to Oregon in two months where she has been offered a Ryan White-related job.

Gray distributed invitations for the St. Hope Foundation anniversary celebration.
