Call to Order: Cecilia Smith-Ross, Chair, Ryan White Planning Council, called the meeting to order at 11:30 a.m. and asked for a moment of reflection.

New HRSA Initiative Regarding Early Identification of Individuals Living with HIV/AIDS: Charles Henley, Manager, Ryan White Grant Administration Harris County Public Health & Environmental Services, summarized the attached document.

Marlene McNeese-Ward, Bureau Chief HIV/STD & Viral Hepatitis Prevention, City of Houston Health Department, stated that they have not received any guidance but hope to by mid-March. McNeese-Ward stated that this should strengthen collaboration. McNeese-Ward invited the Council to be a co-sponsor for the HIP HOP for HIV event. Last year the goal was to test 15,000 individuals. At least 14,471 were tested. This was the largest single testing event held in the United States. The first HIP HOP for HIV planning meeting will be on Tuesday, February 23, 2010 from 3:00 – 5:00 p.m. at 8000 North Drive in the 1<sup>st</sup> floor auditorium. Some outcomes data from 2009 include: of the 14,471 individuals, 1% tested positive which is extremely high; 20%+ had STD's; for 36% it was the first time tested. Ages that were targeted were 15-35. The actual age groups that made up the majority of participants were 15-24 years of age.
