Priority and Allocations Committee: Greg Monk, Co-Chair, gave the following reports: FY 2010 Ryan White Part A Unspent Funds: *Motion #5*: To approve the attached recommendations for allocation increases from FY 2010 Ryan White Part A funds. *Motion Carried.* Abstentions: Rodriguez, Garza, Mgbere, Martin, Salazar, Macias.

FY 2010 Ryan White Part A Carryover Funds: <u>Motion #6</u>: If there are FY 2010 Ryan White Part A carryover funds, it is the intent of the committee to recommend allocating up to \$500,000 of these funds to Outpatient/Ambulatory Primary Medical Care. **Motion Carried.** Abstentions: Akorede, Martin, Mgbere, Rodriguez, Macias.

FY 2010 RW Part A Unspent Funds: <u>Motion #7</u>: In the final quarter of the FY 2010 Ryan White Part A grant year, after implementing the Council-approved October reallocation of unspent funds and utilizing the existing 10% reallocation rule to the extent feasible, Ryan White Grant Administration (RWGA) may reallocate any remaining unspent funds as necessary to ensure the Houston EMA has less than 2% unspent Formula funds and no unspent Supplemental funds. RWGA must inform the Council of these shifts no later than the next scheduled Ryan White Planning Council Steering Committee meeting. Motion Carried. Abstentions: Akorede, Martin, Mgbere, Rodriguez, Macias.

Report from Office of Support: Tori Williams, Manager, summarized the attached report.

Report from Ryan White Grants Administration: Charles Henley, Manager, Ryan White Grant Administration (RWGA), Harris County Public Health and Environmental Services, summarized the attached report. Henley added that the first six months there have been 5,300 unduplicated clients, of which 804 were new clients. RWGA has added a new performance measure which will look at the capacity of making an appointment at a Ryan White funded primary care agency within 15 days.

Report from the Part B and State Services Administrative Agent: Patrick Martin, Program Development Director, The Houston Regional HIV/AIDS Resource Group summarized the attached report. Martin added that more rural agencies are applying for Ryan White funding.

New Business:

HOPWA /Advisory Task Force, City Housing Department: John Tuttle stated that two Town Hall meetings were held. The next Task Force meeting is on November 16, 2010.

Latino Task Force on HIV/AIDS: Steven Vargas stated that they hosted several AIDS Awareness events. However, testing was down 50%. It appears as if members of the Hispanic community are afraid of the government around immigration issues. Vargas thanked the Council for holding the Living Healthy with HIV event at the Ripley House next February 5, 2011.

HIP HOP for HIV Awareness Event: Ruben Rosas thanked those that volunteered to help with the Hip Hop for AIDS Awareness event. See the attached flyer describing a volunteer appreciation get together next week.

Incarcerated: Patrick Martin stated that the Serving the Recently Released (SIRR) meetings continue to go well. Martin thanked Vargas for helping to get AAMA back in the group. The December network meeting will feature the MHMRA staff who work in the jail system. In 2011, meeting times and dates will stay the same, namely, the fourth Wednesday of every month at 9:00 a.m.

M-PACT: Ruben Rosas stated that M-PACT is joining Bee Busy, Inc. for a fundraiser for the Youth Task Force.

Adjournment: Motion #8: it was moved and seconded (Monk, Mgbere) to adjourn the meeting at 12:55 p.m. Motion carried.
