Affected Community Committee: Ruben Rosas Co-Chair, reported on the following:

2011 Public Hearings: the recommended services priorities and allocations were presented at the second Public Hearing on June 28, 2011.

Committee Training: HIV and the Incarcerated: Michael Bass, a member of the Planning Council, student at the UT School of Public Health and staff member at AIDS Foundation Houston, gave a presentation on HIV and the Incarcerated. The next meeting will be next Tuesday at noon. The topic will be "HIV and Transgender Issues". Everyone is invited to attend.

Operations Committee:

HIP HOP for HIV Awareness: Dr. Beverlee Solomon, Council Liaison to the event, reported that the Council has recruited 23 volunteers for the event. The goal was 20 volunteers. The Operations Committee met in July and agreed to distribute 200 HIP HOP concert tickets provided by the City Health Department to 18 – 35 year old HIV positive individuals through case managers at Ryan White funded primary care sites, Part C funded agencies and Texas Children's Hospital. Unused tickets will go to HIV organizations that are affiliated with a Council member.

Report from Office of Support: Tori Williams, Manager, summarized the attached report.

Report from Ryan White Grants Administration (RWGA): Charles Henley, Manager, Ryan White Grants Administration, HCPHES reviewed his attached report and stated the following:

- For the first time in several years the Houston EMA met the WICY requirements for all populations other than children
- There will be carry over funds to reallocate in the amount of \$535,000. Most of these are MAI funds (\$415,000).
- At this time, there is only one request for the remaining \$120,000.
- RWGA is working with METRO to expand the number of available bus passes. At this time there are three types of passes: 1900 individual passes that are time based, cost \$52/pass and are renewable only to the individuals that have had these passes in the past (grandfathered passes); 100 annual, time based passes that cost \$52/pass and will not be renewed next year; and, if the Council agrees, 1100 time based passes at \$347/pass. When averaging the 1900 "grandfathered" \$52 passes with the 1100 \$347 passes, it averages to \$160 per pass for 3,000 total passes next year. The Council will need to decide if they wish to purchase the \$347 passes.

Report from The Resource Group: Patrick Martin, Program Development Director, The Houston Regional HIV/AIDS Resource Group summarized the attached report. On August 5, 2011, Nikita Lamar will be leaving the agency so her position will need to be filled.

New Business:

HOPWA: Melody Barr stated that RFP's are out on the website at: www.Houston.tx.gov under the Housing Development Department. Call 713-868-8300 to sign up for either of the two free workshops. RFP's are due at the end of August. HOPWA will be awarding approximately \$7.6 million.

Latino Task Force on HIV/AIDS: Steven Vargas, summarized the attached report.

SIRR: Martin stated that last month the SIRR Coalition had a presentation on "Medicaid: Before and After Heath Care Reform". Linda Cantu from Bristol-Myers Squibb will be returning in late July to finish the presentation as there were so many questions she was unable to finish her presentation.

M-PACT: Ruben Rosas stated that: 1) the group worked with Houston Health Department and their mobile unit and were able to test 35 people at the Pride Festival/Parade. One person tested positive. 2) The Task Force will be organizing activities to recognize National GLBT HIV/AIDS Awareness Day on 9/27/11.

Legislative Updates: Januari Leo stated that the 82nd Texas Legislation Session has officially ended. Although the ADAP shortfall of \$19 million was not met, there is a rider within the Budget that suggests that the shortfall be met by asking the Texas Department of State Health Services to reallocate funds assigned to Medicaid.

Announcements: Escalante stated that 157 veterans were tested at the Veterans Hospital on June 27 as a part of National Testing Day activities held throughout the City.

Adjournment: <u>Motion #12</u>: it was moved and seconded (Vargas, Rosas) to adjourn the meeting at 1:02 p.m. **Motion carried**.
