Call to Order: Cecilia Smith-Ross, Chair, Ryan White Planning Council, called the meeting to order at 11:32 a.m.

Welcoming Remarks: Smith-Ross welcomed the Project LEAP students and their teacher, Danielle Houston from the Center for AIDS. Smith-Ross introduced the new Health Planner for the Office of Support, Jennifer Hadayia. Smith-Ross thanked the following individuals for their invaluable help with the ten 2011 Town Hall Meetings: Cecilia Smith-Ross, Ruben Rosas, Steven Vargas, Chris Escalante, Steven Schurmann, Charles Henley, Carin Martin, Patrick Martin, Anna Langford, Diane Beck and Tori Williams. Smith-Ross concluded this portion of the meeting with a moment of reflection.

Training: "The Future of Medicaid": Linda Cantu, Associate Director, Healthcare Alliance Liaison, Bristol-Myers Squibb Company and Randall Ellis, Senior Government Relation Coordinator, Legacy Community Health Services walked members through the attached power point presentation entitled: "Securing the Future of Medicaid".

Adoption of the Agenda: <u>Motion #1</u>: it was moved and seconded (Givens, Giwa) to adopt the agenda. Motion carried.

Adoption of the Minutes: <u>Motion #2</u>: it was moved and seconded (Barr, Rosas) to adopt the July 14, 2011 minutes. Motion carried. Abstentions: Akorede, Giwa, Gonzalez, Johnson.

Public Comment: Rosas read the guidelines regarding public comment. Smith-Ross announced that each person would have 3 minutes in which to present their comments.

Beverly DeJean, Project LEAP student, thanked the Council for inviting Project LEAP students to attend today's meeting.

Larry Pelky stated that his company, PharmaHealth Specialty Pharmacy, offers a service package for people who are HIV+ and need medication and/or nutritional supplements. Please see Pelky after the meeting if interested in learning more about their services.

Assessment of the Ryan White Part A Administrative Mechanism: <u>Motion #3:</u> Approve the July 2011 Assessment of the Administrative Mechanism Report noting that no corrective action is required. Commend Charles Henley and his staff for another year of outstanding work. Motion carried.

How To Best Meet the Need: Medical Nutritional Therapy: <u>Motion #4</u>: Ask the Part A and Part B Administrative Agents to encourage case managers to let clients, especially minority clients and women, know about the availability of Medical Nutritional services. Discussion: one member asked why the Council should vote on something that is already included in the vendor's contract. Williams pointed out that case managers provide a different route for getting information to consumers. The committee wants case managers and doctors to be aware of the service so more minority and women clients are aware of this service. C. Martin stated that this request will be discussed at the next meeting of Ryan White funded physicians and at the semi-monthly meeting of case managers. *Motion failed.* Yeas: Garner, Rodriguez, Barnett. Abstentions: Givens, Macias. Remainder of those members in attendance: No. See below for detailed voting records.

<u>Motion #5</u>: Ask the Part A and Part B Administrative Agents to encourage case managers and Ryan White funded primary care sites to let clients, especially minority clients and women, know about the availability of Medical Nutritional services. Discussion: Members continued to discuss barriers to this service.

<u>*Motion #6</u>: it was moved and seconded (Turner, Givens) to call for the question. Motion carried. Nay: Garner. Abstentions: Macias, Rodriguez, Barnett.</u>*

Regarding Motion #5 above, Motion carried. Abstentions: Giwa, Macias.

How To Best Meet the Need: Bus Passes: <u>Motion #7</u>: Keep the current bus pass system as is with 1900 "grandfathered" passes, approximately 100 non-renewable time based passes available at \$52 per pass and Q cards for all others. **Motion carried**. Nays: Barnett, Leo. Abstentions: Giwa, Barr, Givens, Macias, Ray, Turner.

How To Best Meet the Need: Bus Passes: <u>Motion #8</u>: Conduct a focus group to look at the Q cards, how they are issued and renewed: and to look at barriers in order to hopefully make improvements to this service. **Motion carried.** Abstentions: Macias, Gonzalez.

Quarterly Committee Report: FYI: See the attached report.

Comprehensive HIV Planning and Ad Hoc EIIHA Strategy Committees: No report.

Affected Community Committee: Ruben Rosas, Co-Chair, reported on the following: Committee Training: HIV and Transgender Issues: Cristan Williams, Executive Director, Transgender Foundation of America, gave a presentation on HIV and Transgender Issues.

August Committee Training: Norma Acker, former case manager at Fort Bend Family Services will be providing information on HIV in Rural Texas at 12 noon on Tuesday, August 16, 2011at the Center for AIDS.

HIP HOP for HIV Awareness event: Escalante stated that 7,950 individuals were tested for HIV during this 30 day event. It is not yet known how many individuals tested positive.

Operations Committee: Morénike Giwa, Co-Chair, stated that there is no report. See the attached, updated schedule of speakers for the remainder of the 2011 Council meetings.

Priority and Allocations Committee: Linda Hollins, Co-Chair, gave the following reports:

FY 2011 Targeting Percentages: <u>Motion #9</u>: To adjust the FY 2011 Primary Medical Care targeting percentages for Community Based and Public Clinic Primary Care, including Women at the Public Clinic, so that they are aligned with the percentages approved by the Council for FY 2012. Motion carried. Abstentions: Macias, Leo, Barr, Barnett, Mgbere.

Allocation Increases: <u>Motion #10</u>: Approve the attached allocation increases using FY 2010 Ryan White Part A and Minority AIDS Initiative (MAI) carry over funds. Motion carried. Abstentions: Macias, Leo, Barr, Barnett.

FY 2011 Unspent Funds: <u>Motion #11</u>: In the final quarter of the FY 2011 Ryan White Part A grant year, after implementing the Council-approved October reallocation of unspent funds and utilizing the existing 10% reallocation rule to the extent feasible, Ryan White Grants Administration (RWGA) may reallocate any remaining unspent funds as necessary to ensure the Houston EMA has less than 5% unspent Formula funds and no unspent Supplemental funds. RWGA must inform the Council of these shifts no later than the next scheduled Ryan White Planning Council Steering Committee meeting. Motion carried.
