**Call to Order**: Cecilia Smith-Ross, Chair, Ryan White Planning Council, called the meeting to order at 11:36 a.m. and asked for a moment of reflection.

Training: HIV-Hepatitis C Co-Infection: Ben Barnett, MD, Professor of Medicine, University of Texas walked members through the attached power point presentation entitled: "HIV and Hepatitis C Co-infection Update".

Adoption of the Agenda: <u>Motion #1</u>: it was moved and seconded (Givens, Monk) to adopt the agenda. *Motion carried.*

### **Reports from Committees: Quality Assurance Committee**: No report.

**Comprehensive HIV Planning and Ad Hoc EIIHA Strategy Committees:** Sherifat Akorede, Co-Chair, reported on the following:

2012 Comprehensive Plan: See the attached "AT-A-GLANCE" document which outlines the 2012 Comprehensive HIV Planning process. All Council members are encouraged to participate on the Leadership Team or a workgroup in order to provide input into this important process.

**Affected Community Committee:** Eddie Givens gave the following report: Committee Training: HIV in Rural Texas: Norma Acker, former case manager at Fort Bend Family Services provided information on HIV in Rural Texas.

**Operations Committee**: Morénike Giwa, Co-Chair, reported on the following: 2011 Attendance Records: See the attached attendance records.

How to Best Meet the Need: Project LEAP: The Operations Committee continues to "fine tune" the service definition for Project LEAP. Hopefully, the committee will finalize its recommendations for review by the Steering Committee and Council in September 2011.

Council Applicants: The Operations Committee will be having four-hour meetings in September, October and November in order to interview and make recommendations to the Chief Elected Official (CEO) regarding all who have submitted an application for Council membership in 2012. At this time, there are five members who will, due to term limits, will be retiring from the Council in December 2011.

## Priority and Allocations Committee: No report.

Report from Office of Support: Tori Williams, Manager, summarized the attached report.

**Report from Ryan White Grants Administration (RWGA):** Charles Henley, Manager, Ryan White Grants Administration, HCPHES, summarized the attached report.

**Report from The Resource Group**: Patrick Martin, Program Development Director, The Houston Regional HIV/AIDS Resource Group summarized the attached report and introduced Yolanda Jones, their new Quality Assurance Coordinator.

### New Business:

HOPWA: Barr stated that they have extended the due date of their RFP to September 15, 2011 at 3:00 p.m. There will be a Host Providers meeting on September 16, 2011.

Latino Task Force on HIV/AIDS: Escalante stated that they will be participating in a Fiesta Patrias parade on Saturday, September 17, 2011. October 15, 2011 is National Latino HIV Testing Day; plans are to have booths set up at both Ripley Centers.

SIRR: Martin stated that presentations were made at the August meeting by the following organizations: AAMA, the City of Houston reentry program and Michelle Gould from Texas Christian University. TCU are doing a research project with the Texas Department of Criminal Justice (TDCJ) on an intervention program with HIV+ people being released to the community. Another research project with the University of Texas Medical Branch (UTMB) Correctional Managed Care is being discussed. Harris County Jail is doing some following up interviews on what is and what is not working regarding access and barriers to care.

M-PACT: Turner asked members to review the attached flyer describing MPACT's September 27, 2011 event. Turner will be on the Debra Duncan show on September 26, 2011 to promote the event.

AIDS Trial Network: Giwa stated that one of the subcommittees needs members. She will forward the application form to Williams for distribution. In Houston there are several advisory boards related to research. On September 22, 2011 at 5:30 p.m., The Center for AIDS is holding an informational meeting with the different advisory boards. One item of discussion will be about bringing the different cabs into one unified Houston cab so that they can be more competitive for funds.

Legislative Updates: Leo stated that the Texas Department of State Health Services (DSHS) is searching for ways to come up with money so they do not have to ask for so much money in the future.

Texas HIV/AIDS Coalition: There is a planning meeting in Austin on October 15, 2011. Discussions will include how to: give the coalition more legs, be more sustainable and create a mission statement.

Announcements: Akorede reminded members that their participation is needed on the Leadership Team and workgroups for the 2012 Houston Area Comprehensive HIV Services Plan.

Adjournment: The meeting was adjourned at 12:50 p.m.
