Syphilis: Finley stated that lots of people are currently involved in the HIP HOP for HIV Awareness testing event. The Syphilis Task Force is spreading the word as evidenced by 6000 hits on their web page and 5000 friends on their Facebook page.

AIDS Trial Network: Giwa stated that the next meeting will take place in late July/early August. Enrollment of Domestic US Women in clinical trials is currently taking place. The local CABs are meeting at the same times and places each month.

SPNS Grant: HIV and the Homeless Program: Miertschin stated that the posting for a Service Linkage Worker position will close next Friday. Enrollment for that program will begin in September.

Medical Updates: Barnett, MD, stated that the medical community is looking at the possibility of two more people having been "cured" of AIDS in Indonesia. Unlike the first two cases, these two people did not have "long living reservoirs". More study needs to be done on the bone marrow transplant connection to early identification and cure. In the news is information about the new antiviral medication that was originally developed for prevention and lasts for 30 days. Indications are that it might work for treatment as well. The sad news is that the HIV vaccine is not going anywhere.
