Call to Order: Steven Vargas, Chair, called the meeting to order at 12:04 p.m. and asked for a Moment of Reflection.

Welcoming Remarks: Vargas encouraged members to review the attached handouts: Outsmart article re: ACA and Ryan White, written by Morénike Giwa and the recommendation from the Operations Committee regarding 2015 meetings (to be voted on in February 2015). He also encouraged members to participate in the bake-off for the HIV and Aging Coalition. Many thanks to "Team Planning Council" with dessert bakers: Nancy Miertschin, Tracy Gorden, Januari Leo, Teresa Pruitt, Diane Beck and Tori Williams.

Adoption of the Agenda: <u>Motion #1</u>: it was moved and seconded (Pruitt, Bellard) to adopt the agenda. Motion carried. Abstention: Collins-Nelson. Adoption of the Minutes: <u>Motion #2</u>: it was moved and seconded (Turner, Atkinson) to adopt the November 13, 2014 minutes. <u>Motion carried</u>. Abstentions: Bass, Benson, Collins-Nelson, Escamilla, Jones, Pruitt.

Reports from Committees:

Comprehensive HIV Planning Committee: Evelio Salinas Escamilla, Co-Chair, gave the following reports: Collaboration with Local Business Community: Per Activity 8.c. of the Comprehensive Plan which encourages collaboration with local businesses, the Committee created an ad-hoc workgroup tasked with developing a letter for distribution to local chambers of commerce that details speakers available to present HIV-related information of mutual interest at chamber of commerce meetings. Year 2 Comprehensive Plan Evaluation Report: <u>Motion #3</u>: Approve the Year 2 Comprehensive Plan Evaluation Report. Discussion: Alvarez read through the attached highlights. **Motion carried unanimously.**

Health Insurance Enrollment Study: Alvarez gave a verbal report of preliminary findings from the study after which the Committee directed staff to share preliminary findings with the Administrative Agencies. In lieu of a full report in 2014, the Committee directed staff to use the findings to create an electronic message to educate consumers and promote Marketplace enrollment/renewal, and to conduct follow-up phone interviews with study participants when the second Open Enrollment period closes. Feasibility Special Study: Alvarez presented key findings from the Feasibility Study. The Committee will review and discuss the report further in December. See attached presentation. Vargas encouraged members to stay for today's committee meeting that will begin at 2:00 p.m. for more in-depth information.

Affected Community Committee: Gene Ethridge, Co-Chair, reported on the following:
Training: The Needs of the HIV Community in Baytown: FYI: Committee members met at the Legacy-Baytown Clinic, a family practice clinic with a large behavioral health component. The clinic offers HIV testing, eligibility screening, referral to Legacy-Montrose for HIV specialty care, but will provide general care

for HIV consumers if they have a non-HIV issue like a cold or the flu.

FY 2015 Data Report: Eighteen individuals participated in the Joint Committee meeting to review data reports. The administrative agencies agreed to revise all reports so that older age will be broken down as follows: 50 - 64 and 64 & older. The Resource Group agreed to date all of their reports. The Priority and Allocations Committee is going to continue to look at ways to revise the form used for increased funding requests.
