Call to Order: Steven Vargas, Chair, called the meeting to order at 12:05 p.m. and asked for a Moment of Reflection.

During the welcoming remarks, Vargas stated that Eric Twombley passed away in December. Many thanks to Atkinson who worked with the Office of Support and Bering Church to organize a small service for him. Had she not done this, there would have been no opportunity to formally recognize his passing and contributions to the Council. HRSA has contracted with a vendor to collect information on the local impact of the Affordable Care Act on Ryan White. Vargas was recently interviewed for the study and continues to be in touch with the

study administrators who may want to come to Houston for more in-depth interviews. Vargas will work closely with C. Martin since she is also being interviewed for the study. Appreciation was extended to the following individuals for their invaluable help with the HIV and the Affordable Care Act Town Hall Meeting scheduled for Friday, February 6, 2015 at Legacy Community Health Services-Montrose: Ethridge and Ross for recruiting volunteers and volunteers: Ethridge, Ross, Teresa Pruitt, Kevin Moore, Bellard, Tana Brown, Amboree and Herman Finley. The March 14, 2015 Educational Workshop/Town Hall meeting will provide free assistance in tax preparation.

Results of the Mentor Program Study at Thomas Street: Dr. Tom Giordano Baylor College of Medicine & Thomas St. Clinic, former Council member, presented the attached Power Point presentation entitled "Mentor Approach for Promoting Patient Self-care (MAPPS)".

Open Meetings Act Training: Venita Ray, Attorney at Law, Employee at Legacy-Montrose and Coordinator for POP+, former Council member, presented the attached Power Point presentation entitled "Business Must Be Conducted in Meetings Open to the Public".

Public Comments and Announcements: C. Harris read the guidelines regarding public comment. David expressed concern for the City of Houston Service Linkage process, some clients are bring refused services from one agency to the next because they don't have enough letters regarding their HIV status. Vargas advised David to bring this up for the How to Best Meet the Need Process.

Comprehensive HIV Planning Committee: David Benson, Co-Chair, gave the following report: Collaboration with Local Business Community: As a result of the speaker letter and communication with the Metropolitan Chamber of Commerce, Nancy Miertschin was invited to present on HIV and homelessness to the case management staff at Memorial Hermann Southwest Hospital. Miertschin stated that the audience was interesting. Meeting with staff not funded by Ryan White brought it home to her that there is need for more interface with these providers. Lazo added that there has been a 2nd request for the Speakers Bureau, Metropolitan Chamber of Senior Services Alliance request information of the HIV Plus Population and Dr. Patel has been invited to be the speaker.

Staff was instructed to assess whether any additional cost savings could be achieved through pharmacy assistance programs.
